Delta Commnities, Tribes and Advocates

Defeat Newsom's Trailer Bills

Stockton, CA – A coalition of Tribes, environmental justice organizations, fishing groups, conservation advocates, and Delta communities successfully stopped a package of Delta trailer bills that would have had disastrous consequences for the San Francisco Bay-Delta estuary.

Working in close collaboration with the Delta Caucus, co-chaired by Senator Jerry McNerney and Assemblymember Lori Wilson, and with the leadership of Senate President Pro Tem Mike McGuire and Assembly Speaker Robert Rivas, advocates ensured that proposals advanced by Governor Newsom, the State Water Resources Control Board, the California Natural Resources Agency, and the State Water Contractors did not move forward in this legislative session.

The defeated trailer bills would have stripped Tribes and Delta communities of their ability to participate in CEQA review of the Bay-Delta Water Quality Control Plan and would have advanced construction and bonding for the controversial Delta Conveyance Project, including unlimited bonding authority for the Department of Water Resources.”

“Delta communities and allies across California stood up to defend clean water, fisheries, local economies, and environmental justice – and we won,” said **Barbara Barrigan-Parrilla, Executive Director of Restore the Delta**. “This victory shows that the people of the Delta will not be silenced, and that California’s laws protecting public participation, water quality, and the environment cannot simply be swept aside.”

The opposition was broad and vocal. Last week, [more than 50 organizations from across the state formally opposed the trailer bills](#), while thousands of Californians sent emails and phone calls to legislators urging them to reject the package.

Buddy Chaddock, Brian Smith and I represented the West Delta Chapter at two lobbying sessions and the Rally for the Delta.

White Sturgeon Opener Kicks Off with a No-Fee Report Card for This Season

The white sturgeon sport fishing season opens Oct. 1, 2025 through June 30, 2026 for catch-and-release fishing in the ocean, San Francisco Bay, Delta and lower Sacramento and San Joaquin rivers (consult the current regulations to verify open areas and times). Catch-and-release fishing for white sturgeon will continue to be available for anglers under new regulations enacted by the California Fish and Game Commission in August 2025. Previously, catch-and-release fishing was permitted by emergency regulations that were set to expire in September 2025.

Changes to the Sturgeon Report Card

The enacted regulations also include changes to the [sturgeon fishing report card](#). Changes include shifting from a calendar-year approach to aligning with the sturgeon fishing season. Other changes to the card include the kinds of data anglers are asked to record. Anglers will be able to get a sturgeon report card at no fee this new season to help accommodate this change. Starting with the 2026-27 season, sturgeon report cards will be \$8.13, reduced from the previous fee of \$11.06.

With the new report card, anglers are now asked to enter their results from each report card location they fish in a day on a separate line, rather than summarizing an entire trip on one line. CDFW no longer requires the exact lengths of fish caught. Instead, anglers are asked to record how many fish are caught in each location in the size ranges of smaller than 40-inch fork length (FL), between 40–60 in. FL, larger than 60 in. FL, and a simple tally of any green sturgeon. The new card contains a data table expanded from 18 lines to 30, but anglers must purchase a new report card when the table on the first card is full, as is required in all other state fishing report card programs. It is not permitted in regulations to write additional data elsewhere on the card.

CDFW Awards \$2.5 Million for Golden Mussel Response and Boating Access Projects

Today the California Department of Fish and Wildlife (CDFW) announced the award of \$2.5 million in grants for five projects to support public recreational boating access to state waterways. These projects will help prevent the spread of invasive golden mussels, improve public access to California's waterways, expand recreational boating opportunities, and promote stewardship of aquatic resources.

"Supporting safe and reliable access for all boaters and anglers means investing in boating facilities as well as protecting our waterways from invasive species," said CDFW Director Charlton H. Bonham. "A portion of this grant funding will directly support California's response to limiting the spread of golden mussels as part of a larger ongoing coordinated effort."

Looking ahead, CDFW also announced today that the Boating Access Grant Program is now accepting proposals for the Fiscal Year 2026/2027 Boating Access Proposal Solicitation Notice (PDF) and has approximately \$2 million to award. Proposals are due by 4 p.m. on Nov. 7, 2025, through the CDFW WebGrants Portal. Contact BoatingAccess@wildlife.ca.gov with any questions.

CDFW will hold an online Public Workshop (PDF) on Oct. 2, 2025, at 10 a.m., to provide an overview of the Boating Access Program, including eligible activities, program requirements, and granting process. Workshop attendance is not a requirement for submitting a proposal.

Below is a list of awarded projects which will soon begin work supported by CDFW Boating Access Grant Program funds. The Boating Access projects are supported with federal funding from the Sport Fish Restoration Grant Program, administered by the U.S. Fish and Wildlife Service, which provides funds to state fish and wildlife agencies for fishery projects, boating access, and aquatic education.

Invasive Golden Mussel Program

(\$1.3 million to CDFW)

After the discovery of the invasive golden mussel (*Limnoperna fortunei*) in the Sacramento-San Joaquin Delta in Oct. 2024, CDFW responded with approximately \$1.3 million in Sport Fish Restoration/Boating Access grant funding to support the program and projects that prevent the spread of invasive mussels in

California waters. Funds will support the purchase of decontamination units, high-pressure wash stations, improvements to boat ramps and wash stations, and hands-on training for facility staff in boat inspection and decontamination procedures. Experimental Hatchery Strays from the San Joaquin River Restoration Program Find Suitable Habitat and Cold Water on the Tuolumne

LA GRANGE, Calif. – In an exciting and unexpected conservation success, 1,200 adult spring-run Chinook salmon—originally released as part of the San Joaquin River Restoration Program—made their way to the Tuolumne River, where they've found abundant habitat and cold, clean water in which to spend the summer prior to spawning in the fall.

This remarkable development represents an important milestone for the San Joaquin River Restoration Program and highlights the positive impact of the Tuolumne River Partners (Turlock and Modesto Irrigation Districts and the San Francisco Public Utilities Commission) longstanding stewardship and science-based management of the Tuolumne River.

These spring-run Chinook salmon, part of a long-term experimental reintroduction effort on the San Joaquin River, were drawn to the Tuolumne due to its robust spring pulse flows, favorable temperature conditions, and higher water volumes—conditions created under the Tuolumne River Partners' annual operations to support fall-run Chinook.

Drone surveys of nine pools in the Tuolumne River on July 16 counted 1,154 fish; fisheries biologists conservatively estimate that the total number of spring-run may be over 1,500. "In addition to the pulse flow, numerous other factors, including large hatchery releases, extremely wet conditions during migration to sea, and closure of commercial fishing, all contributed to the unprecedented spring-run numbers seen on the Tuolumne in 2025," said FISHBIO Vice President and Senior Biologist Andrea Fuller.

Emergency Relocation Efforts to Prevent Stranding

As spring pulse flows receded and the La Grange Diversion Dam—a historic overpour dam built in 1893—ceased overtopping, the plunge pool at the base of the dam became disconnected from the lower river, trapping a significant number of fish in the pool. In close coordination with the U.S. Fish & Wildlife Service (USFWS), California Department of Fish and Wildlife (CDFW), NOAA Fisheries, and fisheries consulting firm FISHBIO, the Districts supported five relocation operations, successfully moving spring-run salmon to deeper, cooler pools downstream to support their survival over the summer. While CDFW representatives led the effort of physically handling the fish, District staff provided logistical and technical support that aided the relocation efforts.

"We were pleasantly surprised by the number of spring-run salmon identified in the Tuolumne River, and it was impressive to see the way District staff and state and federal fishery agencies worked together – from CDFW designing the relocation plan to TID's Construction and Maintenance team developing a device to safely relocate the fish from the pool at the base of La Grange dam to a more suitable part of the river," said Brad Koehn, TID General Manager.

Science-Driven Monitoring and Conservation Commitment

To better understand and support this unique salmon population throughout their entire lifecycle, the Tuolumne River Partners have voluntarily implemented an extensive scientific monitoring program. This includes real-time monitoring of water quality (including water temperature and dissolved oxygen) at key points along the river, detailed mapping of river habitats, and expansion of on-the-ground surveys to track fish behavior and spawning success. Weekly drone surveys continue to monitor the health and numbers of spring-run Chinook.

"Our commitment to science-based, data-driven measures is making a real difference on the Tuolumne River," said MID General Manager Jimi Netniss. "We're excited to keep this momentum

and work alongside other agencies and partners who share our vision for a healthy river and fish populations.”

To protect the genetic integrity of both spring-run and fall-run Chinook salmon during the late summer and fall spawning season, the Tuolumne River Partners have proposed the [installation of a segregation weir](#) near Old La Grange Bridge that will provide separate spawning areas for spring-run and fall-run Chinook. This would help support the resilience of the overall salmon population.

Together, these efforts will support the significant public investments made in the San Joaquin River Restoration Program.

A Sustainable Path Forward for Spring-Run Salmon

Preliminary data—including submersible video from the CDFW and visual observations during relocation efforts—indicate that the vast majority of the returning fish are hatchery-origin (evidenced by the absence of adipose fins). These findings, coupled with scientific studies specifically conducted on the Tuolumne River, suggest that habitat conditions in the river, enhanced by proactive management, are not only suitable for fall-run Chinook but can also sustain spring-run populations.

Based on the amount of available spawning habitat on the lower Tuolumne River, including newly constructed spawning habitat upstream of Old La Grange Bridge, there is sufficient habitat to support successful spawning and rearing by both spring-running and fall-running Chinook salmon if the available habitat is actively managed to the benefit of both runs. Planned future habitat restoration efforts on the lower Tuolumne River will provide additional habitat to sustainably support spring-run Chinook salmon into the future.

“We’re committed to being good environmental stewards, and it’s great to see our collective efforts pay off with so many fish on the Lower Tuolumne,” said SFPUC General Manager Dennis Herrera.

What's Next?

DCP Water Rights Hearing: Protestants opposing the Delta Conveyance Project are currently presenting their case-in-chief, which is expected to wrap up in late October/early November. The decision is expected sometime in mid-2026. Stay tuned for public participation opportunities!

Bay-Delta Plan: The updated Bay-Delta Program of Implementation and associated environmental documentation are expected to be released in December 2025. The schedule for public comment and panel presentation will be included in this release.
